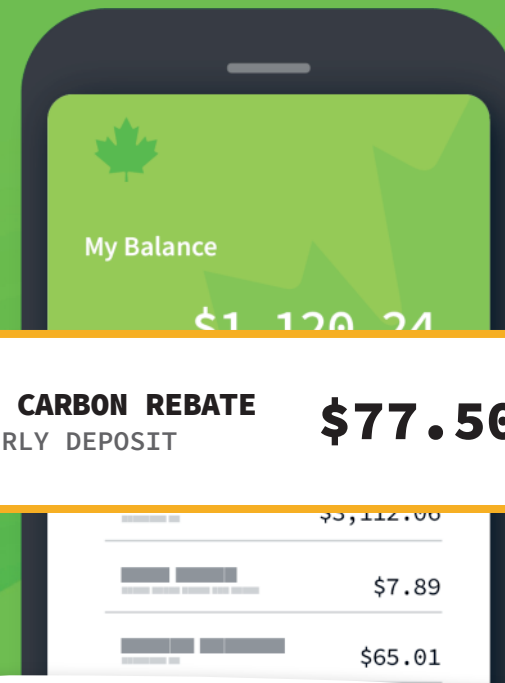

How Carbon Pricing and the Yukon Carbon Rebate works

Here's how carbon pricing works: We make big polluters pay for emitting carbon. We put that money in your pocket.

A price on pollution is a federal initiative. The Yukon's carbon rebate program ensures that all revenues are returned to Yukoners. Money collected through the federal pricing of carbon emissions gets paid out to Yukoners every three months through the Yukon Carbon Rebate.

It's automatic — and everyone gets it, no matter how much money you make.

By making carbon pollution expensive, carbon pricing encourages big polluters to opt for greener alternatives. And, because Yukoners like you are doing your part and going green, you get more money in your bank account each quarter.

Why didn't I get the rebate?

As long as you've filed your taxes, you'll automatically get the rebate. One person in your family will receive it on behalf of your household.

Please note: Your 'Yukon Carbon Rebate' may be called anything in your bank account .

Frequently Asked Questions

How do I get the Yukon Carbon Rebate?

The Yukon Carbon Rebate is sent out automatically every three months by direct deposit or cheque – all you need to do is file your taxes.

I don't see the rebate in my bank account.

It might not be obvious in wording, each bank titles the payment differently. But it is there!

Who is eligible to receive the Yukon Carbon Rebate?

The Yukon Carbon Rebate is applicable to everyone that files their taxes – it doesn't matter how much you make.

I've heard the Yukon Carbon Rebate costs me money – is that true?

This is not true. The vast majority of Yukoners actually profit off of the Yukon Carbon Rebate, getting more money back each year than they've spent on the price on pollution. But the less you spend on fossil fuels, the more net gain you will get from the rebate.

But does pollution pricing actually work? Does it help fight climate change?

It works! Canada's carbon emissions – what causes climate change – are going down, thanks to a whole range of actions our government has taken. That includes making it expensive to pollute, while putting money in your pocket through the Yukon Carbon Rebate.
