Big news for the Yukon and the Far North

Right now, many of us in the North are stuck paying way more than our neighbours down south, and for spotty service. But there's change on the horizon! The CRTC is stepping up to make sure we have affordable, reliable Internet.

The CRTC is now requiring Northwestel to automatically lower our bills when Internet services are disrupted for 24 hours or more. They are also launching a public consultation to develop a subsidy that could make the Internet more affordable for Northerners.

After hearing from over 250 groups, the CRTC is committed to making sure Internet services are more reliable and affordable for everyone in the North.

This is a big win for the North!

Polar Knowledge Canada opens Whitehorse, Yukon office

Polar Knowledge is responsible for advancing Canada's knowledge of the Arctic, strengthening Canadian leadership in polar science and technology. POLAR operated the Canadian High Arctic Research Station and conducts world-class cutting edge Arctic research out of their facilities.

This new office will help build stronger connections with local communities, researchers, and Indigenous knowledge holders, deepening collaborative efforts in Arctic science. By working directly with the people of the North, Polar Knowledge Canada aims to co-develop research, build capacity, and address pressing challenges like climate change, all while supporting the long-term well-being of Northern communities.

This move is an important step in strengthening the organization's commitment to advancing knowledge and fostering Indigenous self-determination in research to better understand and respond to the rapidly changing North.

Canada Health Act

Our government remains committed to ensuring that Canadians receive the health care they need when and where they need it, without having to pay out of pocket. Throughout the last several years, we have seen health care delivery evolve to meet the needs of Canadians. For example, patients now benefit from nurse practitioners diagnosing, referring, and treating them – tasks historically handled only by a primary care physician.

While this evolution has been critical to ensuring access to primary care for Canadians, we have unfortunately also seen an increase in Canadians paying out of pocket for health services that would otherwise be covered by their publicly-funded provincial or territorial health care plan if provided by a physician. Access to care should not be dependent on whether a Canadian has the ability to pay out of pocket.

This is why Minister Holland issued a new Canada Health Act (CHA) Services Policy confirming that, as of April 1, 2026, any medically necessary physician-equivalent services provided by regulated health professionals, such as nurse practitioners, are to be paid for by provincial and territorial health care plans.

Canada's job gains smash expectations and unemployment rate drops

Our government added 91,000 jobs in December, nearly four times the expected amount, marking the highest job growth since January 2023. This is the third positive job report in the last four months.

Our government is focused on protecting and creating well-paying jobs, driving innovation, and boosting productivity, and these efforts are showing real results.

Of the 91,000 jobs added:


- 40,000 were in the public sector
- 27,000 were in the private sector
- 24,000 were from self-employment

Inflation ticks lower to 1.8% in December, thanks in part to GST tax break

We're supporting our workers and boosting our economy – with inflation falling to 1.8% last month.



The Bank of Canada lowered interest rates to 3%, providing welcome news and relief for Canadians. It is particularly good news for homeowners, and for businesses, lowering payments for people renewing their mortgage or looking to buy a first home. Canada was the first G7 country to cut interest rates and is now the first G7 country to do so for a sixth time.

Women in Canada still face significant obstacles to success, including ongoing pay disparities, underrepresentation in high-paying roles, disproportionate caregiving duties, and limited opportunities for career advancement.

Last month, the Honourable Marci len, Minister for Women and Gender Equality and Youth, announced up to **\$40 million** in funding for **170 women's and Indigenous women's organizations.** This funding will help these organizations grow their capacity, enhance their knowledge, and drive meaningful change. It will support efforts to form partnerships and networks, boost community involvement, and develop strategic and financial plans.

By investing in women's and Indigenous women's groups, we're removing barriers and ensuring that more individuals can actively contribute to Canada's economic, social, and political spheres.



Canada is implementing our \$1.3 billion boarder plan

Canada is implementing our <u>\$1.3 billion border plan</u> – reinforcing the border with new choppers, technology and personnel, enhanced coordination with our American partners, and increased responsible for less than 1 percent of fentanyl and illegals entering the United States.

Originally announced in late 2024, it includes:

Put an <u>end to flagpoling</u> - the practice used by some to skirt immigration processes by exiting and re-entering Canada. This means shorter lines at Ports of Entry (POEs) and more officers focused on enforcing the border.

Deployed 60 new drones along our border with the U.S.

Improved the capacity of intelligence sharing with American counterparts by enacting the <u>*High Risk Child Sex* Offender Database Act</u>, which will establishes a publicly accessible database of high-risk offenders convicted of sexual offences against children.

Announced the launching of <u>the first Canadian land preclearance operation</u> in the US, ensuring security threats are intercepted early while streamlining the flow of legitimate travel between Canada and the US.

<u>Reduced the cost burden</u> of removing inadmissible people from Canada by increasing the funds recovered from those individuals.

<u>Aligned hours of service</u> between many Canadian and American POEs, allowing for smoother enforcement.

Completed border security exercises with all provinces, territories, and Indigenous communities.

Introduced an <u>additional protocol to the Safe Third Country Agreement (STCA</u>), in partnership with the United-States (U.S.), to expand the application of the STCA to the entire land border, including internal waterways.

Implemented a <u>partial visa requirement for Mexican nationals</u> to reduce the high number of asylum claims, most of which were refused, withdrawn or abandoned.

Heightened scrutiny of visitor visa applications from countries with the highest rates of abuse, based on a new system of fraud detection.

Removed the additional points that candidates receive under Express Entry for having a job offer.

Implemented reforms to the <u>International Student Program</u> and launched <u>a system to</u> <u>verify every letter of acceptance directly with post-secondary learning institutions for</u> <u>each study permit application</u>.

Proposed new regulations to address misconduct by paid representatives and strengthen the College of Immigration and Citizenship Consultants.

Launched two annual international ad campaigns delivered in over 10 languages to combat misinformation: one to address misinformation about the <u>international study</u> <u>permits and application process</u> and another targeting people seeking information on <u>Canada's asylum system</u>.
